**NOTE:** No goats with herd name of the judges can be exhibited under that judge. An exhibitor shall not present an animal to be shown under a judge that has an ownership or part ownership or by a member of his/her immediate family or household.

**SHOW RULES:** The Breed Standards and Show Rules of NPGA shall govern and be upheld at this show. [www.NPGA-pygmy.com](http://www.NPGA-pygmy.com)

- An original Registration Certificate or approved duplicate is required for all animals six months of age or older. An original certificate or a stamped duplicate, or faxed stamped duplicate application showing the date of receipt by the registry office, is required on animals under six months of age.
- Certificates (or duplicates if applicable) must be presented to the Show Secretary for verification before the judging begins.
- An animal winning Champion or Reserve Champion must have a legible tattoo or microchip (owner must provide reader) that matches the Certificate/Application or the exhibitor will forfeit their award.
- Proof of ownership shall be the name on the Certificate or Application. Persons showing an animal who's Certificate or Application have signed transfers on them must show those animals as agent for the owner on the Certificate or Application.
- Substitution is permitted. Substitution **has to be made before** end of check-in to show.
- Classes and/or Divisions may be combined or divided with the permission of the Show Chairman and judge on show day.
- Exhibitors will bring only healthy animals. If an animal is sick or unhealthy, it will be removed from the show immediately by the show chair.
- Animals with natural horns, disbudded, or dehorned may be shown without regard to discrimination.
- The judge's decision will be final. No protest will be allowed. No reversal of decision will be considered.
- No designated grooming area.
